Job offer:

- Interpreter: **Arabic** (1person) – full time
- Interpreter: **Tigrinya or Amaric** (1person) – full time

The contract length is until 31st of December 2017 with the possibility of extension. All employees are called to offer their services on the island of Lesvos. All applicants should provide the following documentation:

6. **Criminal record certificate** or a **declaration** (Article 8 of Law 1599/1986) with an authenticated signature that: the applicant has not been convicted of an offense punishable by a term of imprisonment of at least one (1) year, as well as offenses of gross physical injury, minors, involuntary abduction, sexual dignity, child abuse, child abuse, children for sexual purposes, pimping,



exploitation of prostitution, childlessness against a minor, and extortion, according to article 22 of Law 4375/2016.

9. PC certificate (optional)

 - a) Apprehension of Greek or English language
 - b) Mother language Farsi/Arabic/Tigrinyan or Amharic
